

## **onX Backcountry Beyond the Trailhead Giveaway Official Rules ("Official Rules")**

### **NO PURCHASE NECESSARY TO ENTER OR WIN.**

The following onX Backcountry **Beyond the Trailhead** Giveaway (the "Giveaway") is open to legal residents of the 50 states of the United States of America and the District of Columbia, (the "USA") only. Any entries received from outside of the USA will not be considered in the Giveaway. The Giveaway is subject to all federal, state, and local laws and regulations. Void in other countries, US territories, and where prohibited or restricted by law.

**ELIGIBILITY:** The Giveaway is open and offered only to legal residents of the USA who are at least eighteen (18) years of age at the time of entry. Employees of onXmaps, Inc., or Sponsor, together with their immediate families (parent, child, sibling or spouse) and/or household members, and any other persons or entities associated with this promotion, are not eligible to participate.

**SPONSOR/ADMINISTRATOR:** The Giveaway is administered by onXmaps Inc. ("onX"), 1925 Brooks Street, Missoula, MT 59801. This Giveaway is administered by onX.

**AGREEMENT TO OFFICIAL RULES:** By participating, entrants agree to abide by and be bound by these Official Rules and the decisions of onX, which are final and binding in all matters relating to the Giveaway. Winning of a Prize is contingent upon fulfilling all requirements set forth herein. Additionally, this Giveaway is subject to applicable federal, state and local laws.

Entrants agree to be bound by the decisions of onX, which are final and binding in all respects, and waive the right to claim ambiguity in the Giveaway or these Official Rules

**WAYS TO ENTER:** The Giveaway begins at 12:00:01 a.m. Eastern Standard Time ("EST") on March 14th, 2026 and ends at 11:59 p.m. on April 24<sup>th</sup>, 2026 ("Giveaway Period"). The Giveaway Period will consist of multiple weekly entry periods (each, a "Weekly Entry Period"), beginning each Saturday at 12:00:01 a.m. ET and ending each week on Friday at 11:59:59 p.m. ET during the Giveaway Period. onX Backcountry's computer is the official time-keeping device for the Giveaway.

No purchase is necessary to win. Participants will receive an entry in the Giveaway for completing all of the following actions:

1. Log in to an existing onX account or create a new account using a valid email address, then complete the official entry form by providing your first and last name.

Any entry that is deemed incomplete, illegible, fraudulent, or corrupted, in the sole discretion of onX, is void and will not be accepted.

**DRAWING AND NOTIFICATION:** The potential Prize Winner will be selected in a random drawing from among all eligible entries received by onX, whose decisions are final and binding. The Prize drawings will be conducted on or before Weekly Entry Period. The potential Prize Winner will be notified by email. If a potential Prize Winner cannot be contacted within three (3) days after the first attempt to contact the Winner onX may select an alternate potential Prize Winner at random from the remaining entries.

**CHANCES OF WINNING A PRIZE:** The odds of winning a prize depend on the number of entries received. One (1) winning entry will be drawn at random from a pool of all valid entries received.
